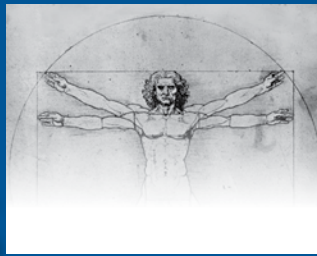

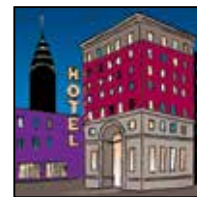

The Centers for Medicare and Medicaid Services' decision to publicly report hospital 30-day readmission rates for various diagnoses on the Hospital Compare web site shone a bright light on hospital performance. And health reform brought new financial penalties, now in their second year, for hospitals with unacceptably high readmission rates, plus new funding for community-wide approaches. These changes have signaled a new chapter in the campaign to reduce preventable re-hospitalizations. The Administration is serious, and it views transparency and payment strategies as tools for both reducing health care costs and improving health care quality.

The National Readmissions Summit is the leading forum on readmissions policy and strategies, including technology-enabled strategies for transitions of care and patient engagement. Hospitals are already looking well beyond just the three diagnoses tracked by CMS and gearing up for new diagnoses to be added, perhaps leading to an all-cause approach.

The Summit will highlight successful hospital strategies and tools, but equally important will feature some of the important new partners and partnerships — home health agencies, long-term care facilities, Area Agencies on Aging, housing support groups, local pharmacies, and of course health plans.

A special preconference will showcase some of the most innovative new mobile apps and technologies to help reduce unnecessary readmissions, and the Readmissions Certificate program will allow participants to take a deeper dive into the subject matter. As always, the conference is available live and archived via a webcast as well as in person.

The National Readmissions Summit will bring together the leading national experts in payment policy, care delivery, operations, and technology and innovation from government, academia, the research community, health plans, hospitals, and community agencies. Highly successful models will be highlighted.

THE READMISSIONS CERTIFICATE PROGRAM

Overview

The National Readmissions Summit is offering a Readmissions Certificate Program in the form of an optional course within the conference for attendees wishing to take a deeper dive into the Summit's subject matter.

The Readmissions Certificate Program curriculum and requirements are as follows:

- Complete pre-conference readings, as needed (up to 6 hours).
- Complete online training modules on preparing for and responding to Medicare readmissions policies and rules (up to 3 hours).
- Consider questions in conjunction with completion of the pre-conference readings (1 hour).
- Attend the entire National Readmissions Summit (12 hours).
- Successfully complete the post-conference online examination (1 hour).

Who Should Attend?

Those who are interested in understanding and working successfully in the new Medicare, Medicaid, and commercial readmissions environment. This may include Government agencies, consumer groups, patient quality organizations, researchers, health plans, health systems, ACOs, medical homes, hospitals, nursing homes, physicians and physician organizations, pharmacies, home health agencies, Area Agencies on Aging, nutrition and meals on wheels organizations, hospices, nurses and other clinicians, medical coding and billing staff, health care financial personnel, compliance staff, legal counsel, and many others.

Learning Objectives

The purpose of the Readmissions Certificate Program is to give participants the understanding and tools necessary to work successfully with the evolving rules for Medicare readmission definitions and penalties. By the end of this training, participants will be able to create an action plan that will outline key initiatives to be taken in their own organizations with respect to preventable readmissions.

Program Description

This is a practical, in-depth program for professionals who want to understand Medicare readmissions issues in particular in the context of their own local setting. The program will be geared toward those who have limited training, but will also cater to those who have increasing levels of knowledge and training in the field. At the end of the program, participants will have 90 days to complete the online examination.

Program Completion

Those who successfully complete the program requirements (see the five bulleted requirements above), including an online post-conference test with a score of seventy percent (70%) or more, will receive a certificate of completion of the Readmissions Certificate Program.

Frequently Asked Questions

IS THE READMISSIONS CERTIFICATE PROGRAM A PROFESSIONAL CERTIFICATION PROGRAM? It is not. The program constitutes an attempt to organize a focused curriculum around implementation strategies and issues pertaining to hospital readmissions, while giving evidence of successful completion of that body of knowledge through the issuance of a certificate of completion.

PLEASE DESCRIBE THE POST-MEETING ONLINE EXAMINATION. The post meeting online examination is a 40-question examination based directly upon the information available in the online course and the faculty presentations in the main Summit. Candidates may take this examination at any time during the ninety (90) days following the Summit. They will be given a web link and a unique username and password to access the examination and will have one hour to complete the examination once commenced. Individuals may take the examination up to three times. New questions will rotate through the examination. A score of seventy percent (70%) or more is required to successfully complete this requirement.

HAS ANY OTHER CONFERENCE OFFERED A COMPARABLE CERTIFICATE PROGRAM? Yes, the Quality Colloquium has offered a Patient Safety Certificate Program, as has the National Medical Home Summit, the National Population Health Colloquium, and the National RAC Summit.
